Child Care Advocacy is an essential topic in February as the opportunity for advocacy is available for programs, teachers, and families to voice their support for the children. The Council supports our community in

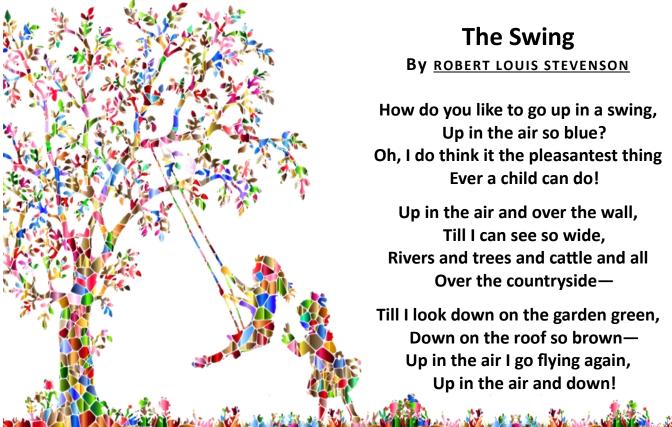

Cauliflower Au Gratin

This recipe for cauliflower au gratin is a delicious and simple recipe that's a great option on your holiday table for those eating low carb.

4 cup cauliflower florets, chopped into bite-sized pieces 6 oz. cream cheese, cut into chunks ¼ cup heavy cream 3 Tablespoons unsalted butter, softened ¼ teaspoon garlic powder ½ teaspoon dried dill sea salt and black pepper, to taste 1½ cup Italian cheese blend, shredded 4 strips bacon, cooked and crumbled 1 Tbsp fresh chives, chopped



Place the top oven rack in the center position and preheat the oven to 400°F. Place the cauliflower in a steamer basket on top of a pot with boiling water and steam until fork-tender, around 6-7 minutes. Remove from heat and transfer cauliflower into a cold water bath to prevent further cooking. Drain well and pat dry. Transfer steamed cauliflower to a large bowl and add cream cheese, heavy cream, butter, garlic powder, and dried dill. Season with salt and black pepper, to taste, and toss to combine. Transfer to oven-safe casserole dish and top with shredded cheese blend and crumbled bacon. Place in a preheated oven and roast until the cheese is melted and nicely browned on top, around 8-10 minutes. Remove from the oven and serve immediately topped with fresh chives.

Mexican Street Corn Salad | Elote Salad

You don't have to travel to Mexico to enjoy the flavors of Elote! You can get all the delicious flavors and textures right here in this Mexican street corn salad recipe.

6 whole corn cobs
2 tablespoons butter
3/4 cup mayo
1/2 cup sour cream
1 large garlic clove
1/2 teaspoon salt
1/2 teaspoon ground black pepper
1/2 teaspoon chili powder
1/2 lime zest from 1 small lime
1/3 cup crumbled cotija cheese
1/2 cup finely chopped red onion



Shuck, rinse and dry corn. Cut kernels off. Melt butter in a large pan over medium heat. Add corn and turn heat up to medium/high. Cook for 3 minutes. Mix to turn over and cook an additional 2-3 minutes. Corn will begin to caramelize, but don't let it burn, so stir occasionally and lower heat if you need to. Turn off heat and allow to cool. In a large mixing bowl, add mayo and sour cream. Using a micro plane, grate garlic clove on top. Next, add salt, pepper, chili powder, lime zest, lime juice, and cotija cheese. Stir to combine. Add corn and red onion, and mix again until coated. Refrigerate to chill. Serve cold, stir before serving.

Fun Clay for Kids

Jell-O Dough

1 cup of flour
1/2 cup of salt
2 tablespoons of cream of tartar
2 tablespoons of vegetable oil
1 cup of warm water
Three ounces of Jell-O – any flavor you wish

Mix ingredients and cook over medium heat until it thickens. Knead until cool enough to touch, takes about 8 minutes. Be careful as it can be quite hot.

Stay Fresh Recipe Stay Fresh Dough

1 cup flour 1/2 cup salt 1 tablespoon alum 1 tablespoon oil 1/8 cup boiling water

Mix flour, salt, alum and oil in a large bowl. Carefully pour in boiling water. Mix well and knead. The mixture will be hot so watch your hands.

Basic Modeling Clay

1/2 cup potato starch or corn starch 1 cup salt 1 cup boiling water

Boil the mixture until its texture reminds you of a soft-ball, then use a waxed paper to knead on. To keep the clay moist, you can place it in an air-tight container and wrap a wet cloth around it. After modeling, the products should be allowed to air-dry. The pieces can be painted after drying is complete.



Occupational Therapy Crafts for Kids

Occupational therapy crafts, and essentially any crafts for kids, are a central part to the typical pediatric OT session. There is a reason why these crafts for kids are so popular on our website: Occupational therapy is founded in craft-making. So, when we, as OTs go back to our profession's roots, we address underlying skill areas through fun and engaging crafts.

Children that make these OT crafts are developing motor skills and cognitive skills, but also the social-emotional and mental development that we as OTs center our profession around. We love to create with crafts. By making crafts with kids, they are not only creating, but also building essential skills. Many of the kids crafts on this site use recycled items or items you've already got in the home. As a special resource, I've added additional OT crafts and ideas that use items in the home, making schooling at home or telehealth services easier when it comes to coming up with occupational therapy teletherapy activity ideas.

OCCUPATIONAL THERAPY CRAFTS

There are so many developmental benefits to crafting with kids. Use the occupational therapy craft ideas in planning in person or OT teletherapy services. Other crafts can be sent home as an OT home program idea. Children can create while working on skills like fine motor dexterity and strength, line awareness, scissor skills, language, self-confidence, problem solving, tool use, and more. What's more, is that kids can create within their interests and will not even realize they are working on skill areas as they craft. Some of these OT craft ideas can pair nicely with homeschooling or schooling at home unit studies and classroom lessons. The best news is that I've strived to include loads of recycled crafts so using recycled materials in craft creation is easy.

KIDS CRAFTS WITH ITEMS IN THE HOME

Items in the home can be used in crafts Try some of these items:

Paper bags

Newspaper

Paper towels

Shredded paper

Plastic food containers

Clothes pins

Cardboard boxes

Tissue Boxes

Wrapping paper

Post-It Notes

Coffee Filters

FINE MOTOR OCCUPATIONAL THERAPY CRAFTS

Occupational therapy crafts many times, center around the development of fine motor skills. Cutting, pasting, tearing, positioning, beading, knotting, sewing...all of these functional tasks require fine motor strength, coordination, grasp, precision, manipulation of craft materials and tools.

OCCUPATIONAL THERAPY CRAFT MATERIALS

But first, what are some crafting materials you can add to your occupational therapy toolbox? Consider adding these items.

Craft pom poms

Clothes pins

Various grades of paper

Scissors

Glue (Squeeze glue in a bottle is best for hand strength development)

Beads

Pipe cleaners

Paper clips

Straws

Cardboard

Yarn

Buttons

Cupcake liners

There are many other craft materials out there that support fine motor development, but with this small list of materials, you can create a huge array of crafts that support skill-building in OT sessions.

FINE MOTOR CRAFTS FOR KIDS

These fine motor crafts for kids work on specific fine motor skills: strength, dexterity, manipulation of materials, in hand manipulation, and pinch and grip. Children creating these crafts gain experience in the small motor skills needed for tasks like object manipulation, tool use, pencil grasp, clothing fasteners, and any small motor activity.

WHAT ARE ACE'S?

ACE's are adverse childhood experiences that have the potential to affect a child's development. Examples of ACE's include witnessing violence in the home, suffering from abuse or neglect, parental divorce/separation and addiction.

WHAT DO WE DO WITH THIS KNOWLEDGE?

Teachers can help children build resiliency through taught skills of self-regulation. By providing children the skills to regulate their emotions and minds, they may be able to better handle the ACE's in their lives.



HOW CAN I LEARN MORE?

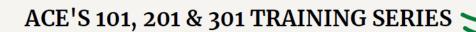

ACE's 101 training aims provides the science and research behind the ACE's study and how it impacts the developing brains of young children. It explains the ACE's scoring system and how children with higher ACE's scores may be impacted in the classroom. It will also discuss the physiological responses ACE's may cause.



ACE's 201 and 301 will begin to apply the science of the 101-Level Adverse Childhood Experiences workshop. Providers will learn skills and ideas that can help mitigate the impact of ACE's on the developing child.

Registering Medical Administrant Training. Step One: Log-in to your ECETP E-Learning account. https://www.ecetp.pdp.albany.edu/mytraining/Login.aspx?ReturnUrl=%2fmytraining%2fdefault.aspx. When you have completed all the above information on line. Please fill out Training Registration Form (page 17) and send your check or money order to the Council. Once your training is complete, your certificate of completion will be available for you to print in your ECETP account.

On the day of the class provider is required to bring the independent study participant guide and the MAT participant's handouts. Provider may use all the materials for the written test and the practical test. The review and testing takes approximately 4 - 5 hours as each person has two (2) chances to pass each part of the test written and practical. The time depends on if provider passes the 1st time or not.

The training provides an overview of medication for both over-the counter and prescription medication; the routes, handling, storage and safe disposal of medication; permission and instruction requirements; preparation and administration techniques; asthma; emergency care and special situations. The MAT training certificate is valid for three years from the date you complete the course. After three (3) years, you may be eligible to take a renewal test online to extend your certificate for another three (3) years. 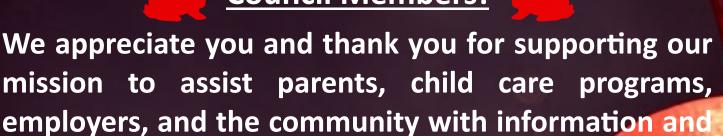
